Complete this request for any transportation loads over the height of 4.25 metres.

Five working days may be required to process a high load permit when a pre-reconnaissance patrol is required to investigate transport route. An additional ten days may be required to organise any power shutdown.

## CONDITIONS OF THE APPLICATION

## The Applicant:

- Declares that the information entered on this Request, including date, time of entry, and maximum height, is correct.
- Agrees to pay all charges incurred by Northpower in connection with the transport of this load.
- Agrees that any Approval granted will be valid only for the date and times entered on this Request.
- Agrees to abide by any directions given by Northpower's escort in respect to the safeguarding of Northpower's network conductors and associated equipment during the transport of this load.
- Agrees to take all due care to prevent damage to Northpower's network, whether or not the load is escorted by Northpower.
- Agrees that the Applicant will be liable for the cost of any damage done to Northpower's network and any associated costs incurred by Northpower as result of the load being transported.
- Understands that the issuing of an Approval by Northpower does not exempt the Approval holder from liability arising from damage to Northpower's network caused by the load, whether it is escorted or not.

Transportation load heights under 5.8 metres may require a pre-reconnaissance patrol to investigate the safety of the transport route. Loads at or over 5.8 metres will require a pre-reconnaissance patrol. A pre-reconnaissance patrol can take five working days to complete investigation.

Any escorts required for a transportation load height under 5.4 metres will be completed at Northpowers costs. Any escort costs for load heights at or over 5.4 metres will be charged to the applicant.

It is a Northpower health and safety requirement that staff undertaking any work between 0200 hours and 0430 hours or for more than four hours in duration between 2200 hours and 0730 hours, is required to have a stand down period of up to nine hours. Costs incurred as a result of this safety requirement for escorts of loads at or over 5.4 metres will be on-charged to the applicant and are additional to any charges for the load escort itself.

An estimate of the anticipated cost of any escort will be provided to the applicant when the height of a load is at or over 5.4 metres.
