Important Information

In receiving this ‘no-interest tree notice’ Northpower (for Northpower owned lines) reserves the right, as is provided for in the Regulations 2003 – specifically Regulations 15, 16 & 17, to accept or not accept this notice as being a valid “no-interest tree notice”.

1. If **accepted** we will advise whether we will remove the tree or the extent of any trimming work to be done.
2. If **not accepted** we will advise the reasons.

Declaration

In providing this “No-interest tree request” I (land owner / occupier) make the following statement that with respect to the conductor (power line) and the tree the subject of this notice;

1. I am legally able to declare “No-interest” in this tree.
2. I am not aware of any protection order relating to this tree.
3. If Northpower accepts this tree as a “No Interest Tree” I give my consent to Northpower to enter onto the property to carry out whatever work Northpower considers necessary to the “No Interest Tree”, now and as long as I own/occupy this property. I also confirm that I have obtained the consent of any other party having a right of access to, or use of the land.
4. I do not request Northpower to remove resultant debris (debris means twigs, small branches and rubbish. Tree trunks and limbs are not considered to be “debris” and will be left safely.)
